

ELLE TENS RENTAL CONTRACT

Thank you for choosing to rent the Elle TENS unit from Bunky Bambino. Please email emma@bunkybambino.com if you have questions about these services.

The following rental agreement will take place between Emma Devin of Bunky Bambino and the individual named below.

When you reach 37 weeks you can use your TENS unit for pain relief before, after, and during your labour and birth. Your TENS unit will be delivered to you any time after you reach 37 weeks of pregnancy.

Our Elle TENS Unit rental cost is \$60.00 + GST/PST for up to 4 weeks. Full payment is required to reserve your unit, an invoice will be sent to you upon receipt of this signed contract. An additional fee of \$15.00 per week or part week is incurred after the 4 weeks rental period has expired. The rental plan begins when full payment and agreement are received by Bunky Bambino Birth Services.

Items included in TENS Unit rentals are:

- Elle TENS unit
- Pack of 4 electrode pads
- 2 Lead wires and 1 spare
- 2 AA Batteries and 2 spare
- Lanyard
- Carrying pouch
- Instructional PDF

Please contact Emma at Bunky Bambino when the unit is ready for return. You can reach us at emma@bunkybambino.com. TENS electrode pads are not to be returned to Bunky Bambino, they can be discarded.

Disclaimer:

- If you have a cardiac pacemaker or suffer from epilepsy you must not use the TENS Unit.
- The TENS must not be worn and or operated while driving a vehicle.
- Do not operate a microwave while wearing the TENS Unit.
- The TENS Unit must NOT be used in a bathtub or shower.
- The TENS Unit is for the sole use of the undersigned only.

Your rental has been cleaned, sanitized, inspected for damage and tested. You will receive it in working order. Any damage or breakage during the rental period will result in the full cost of replacement, of the TENS Unit, which is up to \$200.00.

Cancellation & Refund Policy:

No refunds are offered, even if the TENS unit is not used.
